Sealed bids for BRO-R058 (43), Linn County Replacement Bridge No. 4090007, will be received at: 108 North High, Linneus MO 64653 until 1:00 p.m. on the 29th day of July, 2025, at the office of the Linn County Commission, and at that time will be publicly opened and read. All bids shall be submitted in the form of a hard copy.

The proposed work includes the construction of a 134'-1/2" long, single span, Prestressed Concrete NU-Girder bridge at 30-degree L.A. skew and 0% grade, located on Jaffa Road, over Bear Creek in Linn County MO.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the United States Department of Labor (Federal Wage Rates) and Missouri Department of Labor and Industrial Relations (State Wage Rates), whichever is higher.

The Linn County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The contract, if awarded, will be awarded to the lowest, responsive, responsible bidder complying with the Conditions of the Contract Documents within the Owner's budget. The Bidder to whom the awards are made will be notified at the earliest possible date. The Owner, however, reserves the right to reject any and all Bids and to waive any informality in Bids received whenever such rejection or waiver is in his interest.

The DBE Goal for this project is 5%.

No 2nd tier subcontracting will be allowed on this project.

- (1) **PROPOSED WORK:** The proposed work, hereinafter called the work, includes:

The construction of a 134'-1/2" long, single span, Prestressed Concrete NU-Girder bridge at 30-degree L.A. skew and 0% grade, located on Jaffa Road, over West Yellow Creek in Linn County MO.

(2) **COMPLIANCE WITH CONTRACT PROVISIONS:** The bidder, having examined and being familiar with the local conditions affecting the work, and with the contract, contract documents, including the January 1, 2025 version of the Missouri Highways and Transportation Commission's "Missouri Standard Specifications for Highway Construction," and "Missouri Standard Plans for Highway Construction", their revisions, and the request for bid, including appendices, the special provisions and plans, hereby proposes to furnish all labor, materials, equipment, services, etc., required for the performance and completion of the work. All references are to the Missouri Standard Specifications for Highway Construction, as revised, unless otherwise noted.

It shall be conclusively presumed that they are in the bidder's possession, and they have been reviewed and used by the bidder in the preparation of any bid submitted on this project.

Please note that within the above-listed documents, the term "Commission" shall be replaced with the term "Linn County Commission", and the term "Engineer" is a reference to the Engineer of Record from "McClure".

The contracting authority for this contract is Linn County Commission.

(3) **PERIOD OF PERFORMANCE:** If the bid is accepted, the bidder agrees that work shall be diligently prosecuted at such rate and in such manner as, in the judgment of the engineer, is necessary for the completion of the work within the time specified as follows in accordance with Sec 108:
