The Missouri Highways and Transportation Commission is requesting the services of a consulting engineering firm to perform the described professional services for the project included on the attached list.

If your firm would like to be considered for these consulting services, you may express your interest by responding to the appropriate office, which is indicated on the attachments. Limit your letter of interest to no more than three pages. This letter should include a statement to indicate your firm's understanding of the project. It should also include any other information which might help us in the selection process, including key personnel you would assign to the project and the backgrounds of those individuals, and any subconsultants you would propose to use, and an indication of your firm's approach to promoting and developing a diverse workforce. MoDOT is committed to reflecting the diversity of the communities we serve and we expect our partners to do the same. We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information. In addition, please attach one page with detailed information on similar projects that your key personnel have worked on. Indicate the role your key personnel played in the projects and include reference contact information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm. We also encourage both DBE firms and non-DBE firms to consider joining MoDOT's Mentor/Protégé program whenever possible as part of a MoDOT project.

MoDOT will evaluate firms based on: Project Understanding & Innovation, Past Performance, Qualifications of Personnel Assigned, General Experience of Firm, Familiarity/Capability, Accessibility of Firm & Staff. Firm's not providing a response on approach to workforce diversity will be considered non-responsive to this solicitation. Firm's that are not current on all of the required prequalification categories found in MoDOT's Approved Consultant Prequalification List at the date of the solicitation expiration will be considered non-responsive.

Location:	Route I-55 over the Meramec River between St. Louis and Jefferson Counties. Project involves twin bridges A0609.	
Proposed Improvement:	The proposed improvement involves rehabilitation of the twin bridges A0609. The rehabilitation includes hydro demolition and placement of new wearing surface (Latex or Polyester), deck repairs, substructure repairs, conversion of end bents to semi-integral, replace pin-hanger assemblies, bearing and expansion joint replacement, structural steel repairs and coating near expansion devices, barrier repair, traffic control and various roadway items.	
Length:	0.28 miles	
Approximate Construction Cost:	\$18,800,000	
DBE Goal (if applicable)	0%	
Consultant Services Required:	Scope of Services - The consultant will provide professional, technical and other personnel, equipment, material, and all other things necessary for field inspection of the rehabilitation of twin bridges A0606. Services to be provided by the consultant include field inspections of all work and contract activities required for the bridge rehabilitation, on-site materials testing, project documentation, measurement and payment of work performed, preparation of change orders and estimates, Wage Rate and Commercial Useful Function Interviews, bulletin board inspections, traffic control reviews and preparation of as-built construction drawings. For the bridge coating inspection, MoDOT requires coating inspection staff to be NACE Level 2 or equivalent. Also, on an as needed basis, the consultant shall provide a quality assurance Certified Welding Inspector that is familiar with AASHTO/AWS, D1.5 to assist the Commission with structural steel weld repairs and non-destructive testing oversight. The consultant will be required to use AASHTOWare Project for all project documentation and record keeping. The consultant inspection staff shall be Advance Workzone and OSHA 10 trained and MoDOT Technician Certified in concrete field and strength. Project may require nightwork at times.	
Other Comments:	Interviews or presentation will not be required for the consultant selection. Job J6I3290 is scheduled for a contract award date of November 2025.
