Sealed bids for the construction of Randolph County Bridge #3690011; Federal Project BRO-R088(23) will be received at the office of the Randolph County Commission, Randolph County Courthouse, 372 Highway JJ, Suite 2C, Huntsville, MO 65259 until **10:00 o'clock A.M. (Prevailing Local Time) on the 22nd day of October, 2025** at the office of the Randolph County Commission, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes:

Construction of one (1) single span (55'-0") W21x132 Steel I-Girder bridge.

Federal Project BRO-R088(23); Structure No. 3690011 Located on County Road 2520 over Moniteau Creek in Section 34, Township 53N, Range 14W in Randolph County, Missouri

All bidders must purchase plans and specifications through Hutchison Engineering, Inc. and be on the plan-holder list in order to bid the project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The Randolph County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Randolph County Commission reserves the right to reject any or all bids.

The DBE Goal for this project is 6%..

No 2nd tier subcontracting will be allowed on this project.

Proposals must be on forms provided and all unit price bids, extensions and totals provided thereon shall be completed fully.

The project will be awarded to the lowest, responsible, responsive bidder.
