- Job J6P3510C Route Various VARIOUS County. ADA improvements various locations in the St. Louis District, the total length of improvement being 0 miles.
- Job J6S3578 Route 61/67 ST LOUIS County. Coldmill, resurface, bridge rehabilitation, and ADA improvements from north of I-270 on Route 61 to route 186 near Oakville, the total length of improvement being 4.25 miles.



The following projects are planned to be advertised in the November 14, 2025 letting, at which time plans and specs will be posted:

- Job J6S3557 Route 67 ST LOUIS County. Coldmill, resurface, ADA improvements, signals and signing on Route 67 from I-70 to Route D in Maryland Heights, the total length of improvement being 3.83 miles.
- Job J6S3625 Route 67 ST LOUIS County. Coldmill, resurface, ADA improvements and signals on Route 67 from north of I-270 to west of St. Charles Street in Florissant, the total length of improvement being 1.79 miles.
