The DBE Goal has been updated from 8% to 0% for the project referenced above and bidders are hereby instructed to make the following two (2) changes to the Bid Documents and to consider these changes included herein when making a Bid for the work specified in the Bid Documents:

Item #1: Replace Invitation for Bids. The Invitation for Bids (Page i of the Bid Document) has been updated to change the DBE Goal to Zero Percent (0%).

Discussion: The DBE Goal for the above referenced project has been changed from 8% to 0%. A replacement Invitation for Bids page is included in this addendum. No other changes were made to the Invitation for Bids.

Item #2: Replace the first page of the DBE Submittal Forms. The DBE Submittal Forms (Page 19 of the Bid Document) have been updated to change the DBE Goal to Zero Percent (0%).

Discussion: The DBE Goal for the above referenced project has been changed from 8% to 0%. A replacement DBE Submittal Forms page is included in this addendum. No other changes were made to the DBE Submittal Forms.

Addendum Summary

The two (2) changes included in this addendum affect two (2) pages of the Request for Bid document, as summarized below:

Item #1: This addendum includes a replacement page for Page i of the Request for Bid document. Bidders are instructed to consider this replacement page when interpreting the scope of work for the project and when formulating their bid.

Item #2: This addendum includes a replacement page for Page 19 of the Request for Bid document. Bidders are instructed to consider these replacement pages as part of their bid for the project.

INVITATION FOR BIDS

Roadway and Sidewalk Improvement Project

Sealed bids for the Craig Road Improvement Project STP-5563(603), will be received by Kevin Mulligan, Civil Engineer, at the Creve Coeur Government Center, which is located at 300 N. New Ballas Road, Creve Coeur, Missouri 63141, until **10:00 A.M. (Prevailing Local Time) on NOVEMBER 6, 2025**, after which time the bids will be publicly opened and read. All bids shall be submitted in the form of paper bids. Late bids shall be returned, unopened.

The proposed work includes: partial reconstruction, asphalt resurfacing, new sidewalk construction, and sidewalk and curb ramp improvements on Craig Road, Olde Cabin Road, and Office Parkway from south of Olive Boulevard to Old Ballas Road; and other related work.

Plans and specifications will be available beginning on Thursday, September 25, 2025, and may be obtained from Drexel Technologies, 60 Progress Parkway, Maryland Heights, MO 63043 / www.drexeltech.com / 314-872-0900. A non-refundable fee will be charged.

A pre-bid conference will be held at 10:00 a.m. on Thursday, October 23, 2025. This meeting will be held at the Creve Coeur Government Center (300 North New Ballas Road, Creve Coeur, MO 63141). Attendance at this meeting is optional, but all prospective bidders are encouraged to attend.

Questions, comments, and requests for information regarding the Bid Documents will be received by the City until 2:00 P.M. on Tuesday, October 28, 2025.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Creve Coeur hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, sexual orientation, gender, gender identity, disability, familial status, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, Latest Edition. The contractor questionnaire must be on file at least seven (7) days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Creve Coeur reserves the right to reject any or all bids. By submitting a Bid, a Bidder agrees that their Bid will not be withdrawn for a period of sixty (60) days except as provided herein, subsequent to the specified time for receipt of Bids and further agrees to the terms and conditions of this Invitation and the Bid Documents regarding the bidding process. No low Bidder shall have a business expectancy merely because their Bid is the lowest one received: until the contract has been awarded, no business expectancy exists. Bids may be withdrawn solely for demonstrated and verifiable clerical or typographical mistake, but not mistake of judgment.

The contract for this project will be awarded to the lowest, responsive, responsible bidder, subject to MoDOT concurrence and confirmation by the Creve Coeur City Council.

The DBE Goal for this project is Zero Percent (0%).

No second-tier subcontracting will be allowed on this project.
