Sealed bids for the Proposal for the Construction of Saline County Bridge #26300081 BRO-B097(53) Replacement will be received at: Saline County Commission, 19 E. Arrow Street, Marshall, MO 65340, until 9:00 A.M. (prevailing local time) on the 15th day of October, 2025, at the office of the Saline County Courthouse, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes:

Demolition of existing bridge and construction of a new 120-foot, single-span prestressed concrete NU-girder bridge, approach roadway work, and any other incidental work in accordance with the plans and specifications. The projec t is located on Pawpaw Trail in Section 21, Township 52 North, Range 19 West, Saline County, Missouri over Bear Creek.

A digital copy of the plans and specifications may be purchased through the office of Great River Engineering (GRE), at 2826 S. A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The Saline County Commission reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsive, responsible bidder.
