St. Louis County Project No. AR-1744, Federal Project No. STP-5506(604) consists of removal and replacement of deteriorated and/or damaged pavement, removal and replacement of traffic signal equipment, removal and replacement of sidewalk and curb ramps, pavement surfacing and texturing, superpave asphaltic concrete overlay, and other incidental items on Charbonier Road from Howdershell Road to Lindbergh Boulevard within St. Louis County in a workmanlike manner.

Contractors and sub-contractors who sign a contract to work on a public works project shall provide a ten (10) hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
