Anthem Claims Summary (2024/2025) –Mr. Denkler reported that medical claims have

increased about 4.7% for the year or \$2.3 million dollars from this time last year.

MoDOT/MSHP Prescription Drug Paid Claims Monthly Comparison (2024/2025) -

Mr. Denkler reported that claims through June decreased about 4.3% PMPM during the

month of June. Pharmacy claims are up 2.6% when compared to this time last year.

Other Business- Mr. Denkler reported Anthem and MU have come to an agreement.

MU's network status will be backdated to April 1, 2025. The three-year agreement

should be signed today. All medical claims submitted by MU during this time will be

reprocessed and paid as in-network.

Mr. Denkler informed the Board that the CarelonRx contract has been finalized.

Mr. Denkler informed the Board that UHC Members received a letter informing them

JCMG will be out of network in September. Fortunately, this change won't affect our

members as long as their provider continues to accept Medicare. Our UHC plan pays the

same for in-network and out-of-network claims.

Mr. Denkler reports his workshop with the Commission went well. The Commission

encourages the Medical Board to look at the Plan's deductibles and co-pays and what

changes could help the plan. The Commission also talked about encouraging employees

to switch from the PPO plan to the HDHP by possibly doubling the Employer HSA

contribution. The HDHP will need changes before 2027 as our deductible will be the

lowest possible to keep an HSA option.

Mr. Padgett made a motion to adjourn. Mr. Smith seconded; motion carried. Meeting

adjourned at 8:25 a.m.
