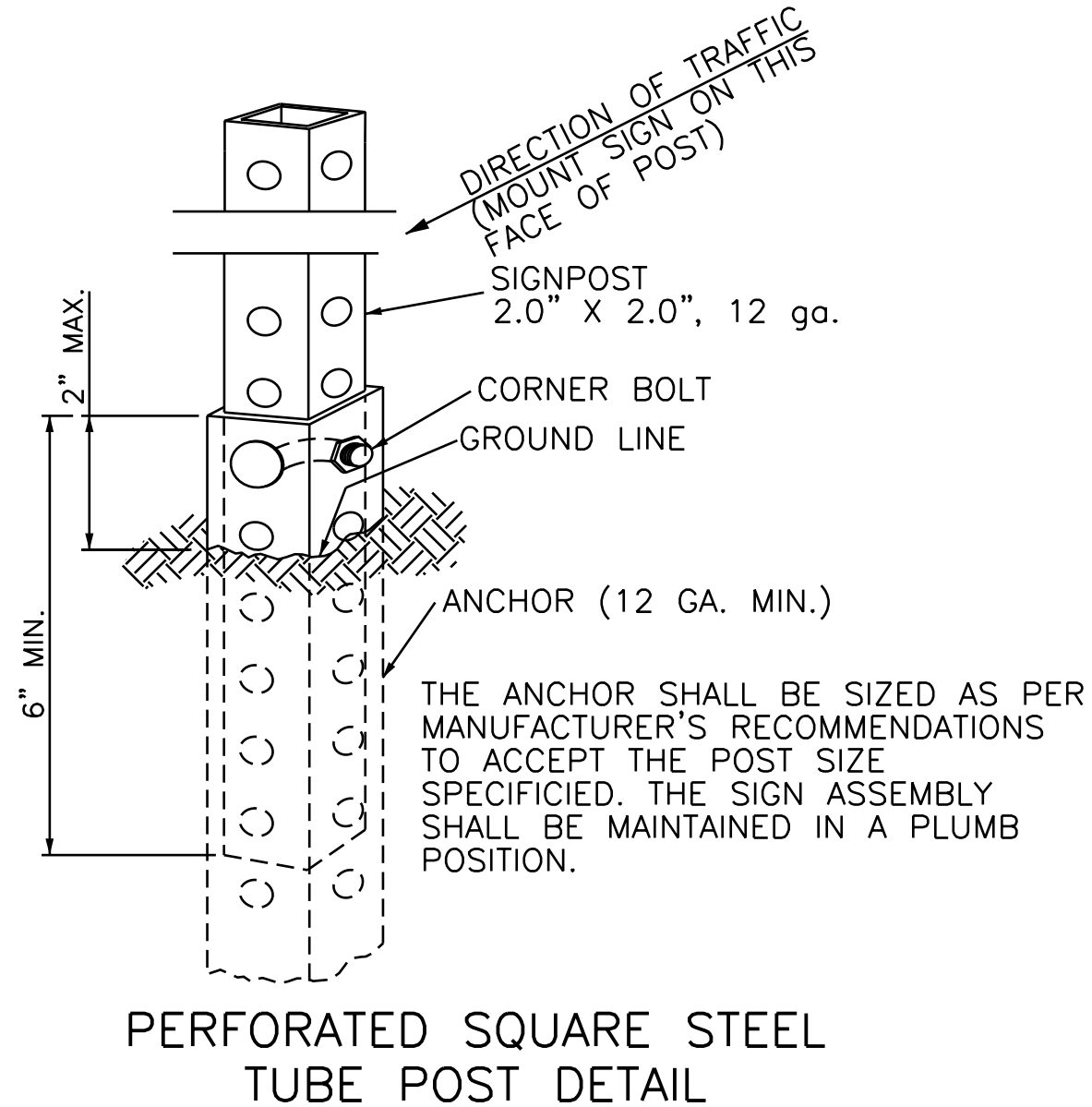

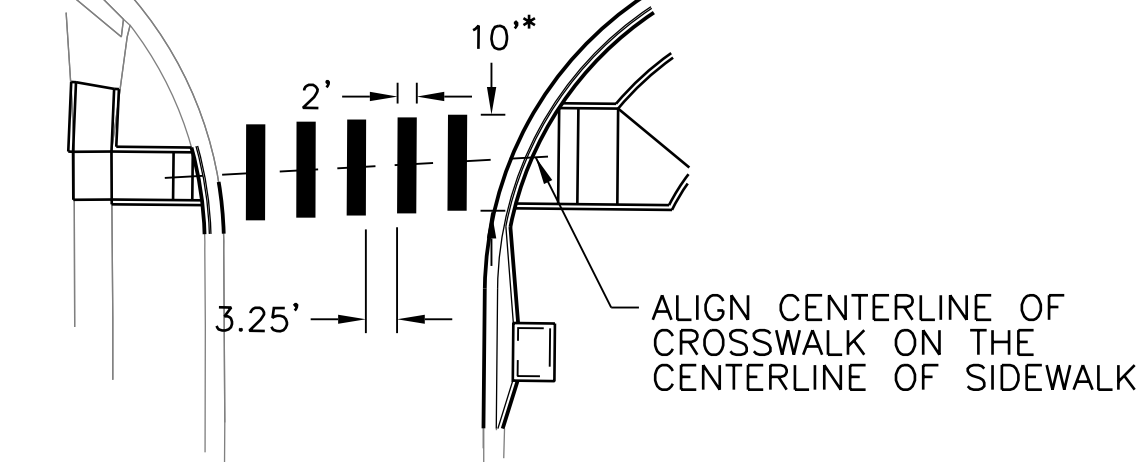
THE SPLICE SHALL CONSIST OF A 12 INCH PIECE OF TUBE, INSERTED 6" INTO BOTH THE UPPER AND LOWER SIGNPOST SECTIONS AND CORNER-BOLTED AT BOTH ENDS.

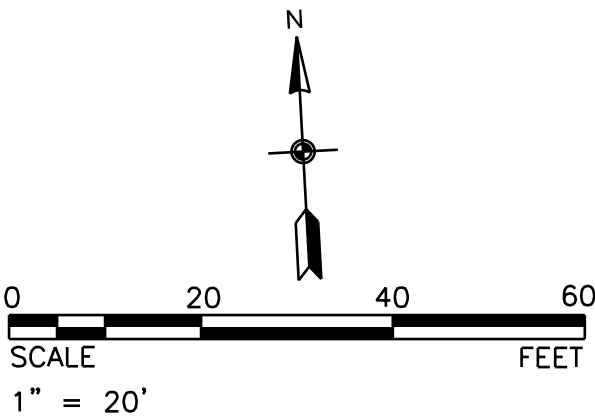
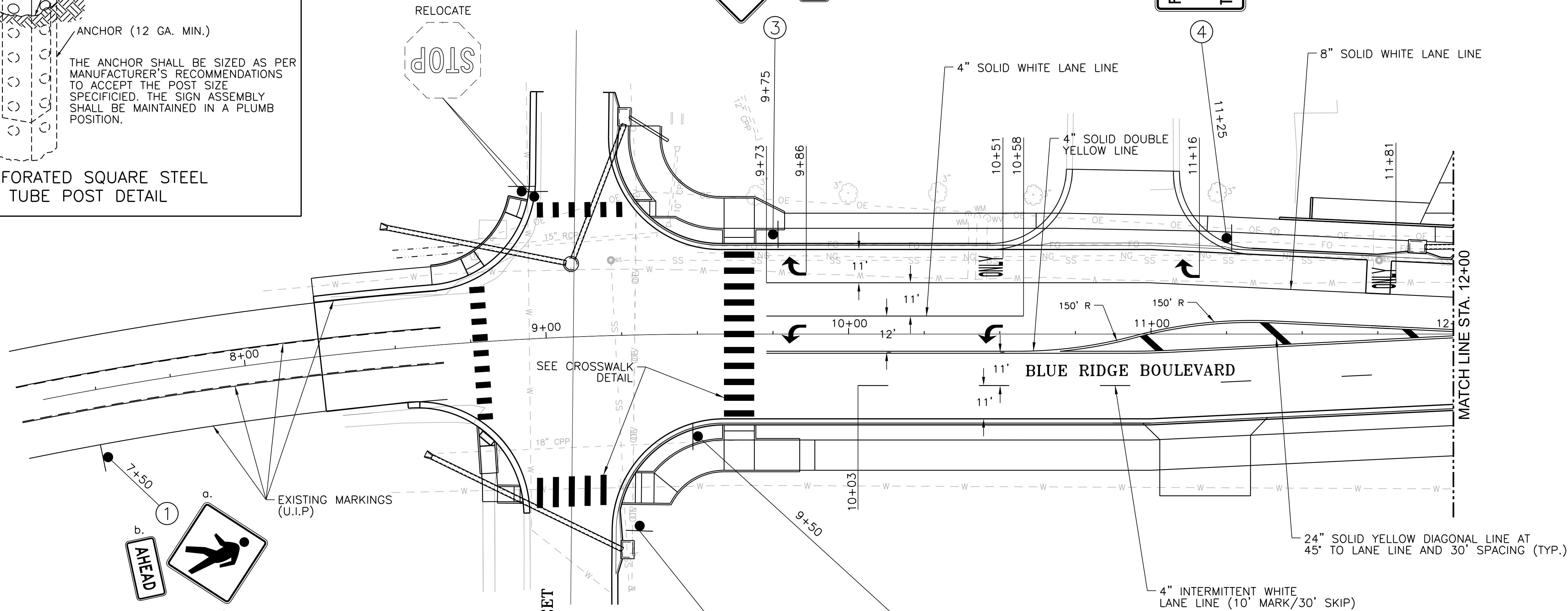
ALL POSTS SHALL BE EMBEDDED A MINIMUM OF 3 FEET.

#### SIGNING NOTES:

1. ALL SIGNING SHALL CONFORM TO THE LATEST EDITION OF THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (MUTCD). DESIGN DETAILS FOR PROPOSED SIGNS (COLOR, LETTER HEIGHT, LETTER SERIES) SHALL BE AS SHOWN IN THE STANDARD HIGHWAY SIGNS MANUAL (LATEST EDITION) UNLESS OTHER DETAILS ARE SHOWN ON THE PLANS.
2. THE LOCATIONS OF UNDERGROUND UTILITIES ARE SHOWN ON THESE PLANS AND/OR THE ROADWAY PLANS IN AN APPROXIMATE WAY ONLY. THE CONTRACTOR SHALL DETERMINE THE EXACT LOCATION OF ALL UTILITIES PRIOR TO ERECTING ANY SIGNS AND AGREES TO BE FULLY RESPONSIBLE FOR ANY AND ALL DAMAGES WHICH MAY BE OCCASIONED BY THE CONTRACTOR'S FAILURE TO EXACTLY LOCATE AND PRESERVE ANY AND ALL UNDERGROUND FACILITIES.
3. ALL EXISTING SIGNS FROM STA. 9+50 TO STA. 19+00 SHALL BE REMOVED UNLESS OTHERWISE SHOWN ON THE PLANS. SEVERAL SIGNS OUTSIDE THE PROJECT LIMITS SHALL BE REMOVED AS SHOWN ON SHEET 13. THERE SHALL BE NO DIRECT PAYMENT FOR SIGN REMOVAL. THE CONTRACTOR SHALL CONTACT CITY ENGINEER, CITY OF GRANDVIEW AT 816-316-4857 TO DETERMINE IF THE CITY WANTS TO RETAIN REMOVED SIGNS AND POSTS. OTHERWISE, THEY SHALL BECOME THE PROPERTY OF THE CONTRACTOR.

#### PAVEMENT MARKING NOTES

1. ALL PAVEMENT MARKINGS SHALL CONFORM TO THE LATEST EDITION OF THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (MUTCD). LEGEND AND SYMBOL MARKINGS SHALL CONFORM TO THE LATEST EDITION OF THE STANDARD HIGHWAY SIGNS BOOK, PUBLISHED BY THE FEDERAL HIGHWAY ADMINISTRATION.
2. THE PAVEMENT MARKING MATERIAL SHALL BE PREFORMED THERMOPLASTIC FOR ALL LINES AND SYMBOLS INSTALLED ON THE PROJECT.
3. WHERE APPLICABLE WHEN PLACING MARKINGS UNDER TRAFFIC, THE CONTRACTOR SHALL USE LANE CLOSURES TO PROVIDE THE REQUIRED MINIMUM CURE TIME FOR THE MATERIAL AS SPECIFIED BY THE MANUFACTURER.
4. ALL CONFLICTING PAVEMENT MARKINGS SHALL BE REMOVED PRIOR TO INSTALLATION OF THE FINAL PAVEMENT MARKINGS.
5. ZEBRA CROSSWALK MARKINGS SHALL BE CENTERED IN THE PATH BETWEEN CURB RAMPS AND SPACED TO AVOID WHEEL PATHS.
6. UNLESS OTHERWISE NOTED, DIMENSIONS SHOWN TO A CURB SECTION INDICATE THE DIMENSION TO THE EDGE OF THE ADJACENT TRAVEL LANE.
7. UNLESS OTHERWISE NOTED, ALL PAVEMENT MARKING SYMBOLS SHALL BE CENTERED IN THEIR RESPECTIVE LANES.
