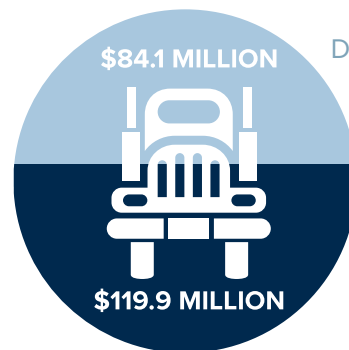

MCS conducts roughly **1,000 safety audits** annually, helping new carriers master their safety responsibilities.

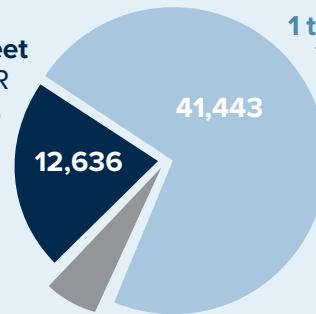
