The bidder will be declared unresponsive if bids are not submitted in accordance with Section 00210 Notice to Contractors on all Projects listed above. The combination of the total prices of the base bids for all Projects listed above will be used to determine the lowest, responsive, responsible bidder. The owner reserves the right to reject any and all bids and to waive any irregularities in the best interest of the City with MoDOT's consent. Contractor should be aware that these are being bid as separate projects and bid forms for both projects must be submitted at the time of bid.

The City of Kansas City, Missouri, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Prior to Bidding, Prime Contractors must have a fully responsive contractor questionnaire on file with the Missouri Highways and Transportation Commission (MHTC) at least seven (7) days prior to the bid opening date. Subcontractors utilized for DBE Goals must appear on the MoDOT/Kansas City Approved DBE List and on the MoDOT DBE Directory located at [http://www.modot.mo.gov/business/contractor\\_resources/bid\\_opening\\_info/bidGenInfo.shtml](http://www.modot.mo.gov/business/contractor_resources/bid_opening_info/bidGenInfo.shtml).

Each bidder must certify that it is not presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from covered transactions by any federal agency and they have not been convicted or had civil judgment rendered within the past 3 years.
