

CAPE LaCROIX TRAIL ENHANCEMENTS From Bloomfield Road Overpass To Shawnee Park Sports Complex TAP-9900(177)

NOTICE TO BID

Sealed proposals will be received for the Cape LaCroix Trail Enhancements from Bloomfield Road Overpass to Shawnee Park Sports Complex - Federal Project No. TAP-9900(177) project at the Office of the City Engineer, City of Cape Girardeau City Hall, 44 N. Lorimier Street, Cape Girardeau, Missouri 63701 until September 9, 2025 at 10:00 am (prevailing local time).

The project consists of removal of existing improvements, grading, widening the existing asphalt trail, constructing new concrete and asphalt trail sections, installing an asphalt leveling course, installing an asphalt overlay, installation of new storm sewer piping, site restoration and other related construction items as stated in the Specifications and as shown on the Project Plans prepared by Bowen Engineering & Surveying, P.C. and dated August 12, 2025 for the City of Cape Girardeau, Missouri.

Proposals will be publicly opened and read aloud on <u>September 9, 2025 at 10:00 AM</u>, local time in the Hub Conference Room at City Hall located at 44 N. Lorimier St. A certified or cashier's check, or bid bond executed by the bidder and an approved Surety Company, in the amount of five (5%) percent of the bid shall be submitted with each Proposal. The sample Bid Bond Form included in the Proposal Documents may be utilized, or another form providing all information indicated on the document in the bid proposal package may be utilized.

All questions concerning the project shall be submitted in writing to the City Engineer, Jake Garrard, P.E. (mgarrard@cityofcapegirardeau.org) by September 5, 2025 at noon. An optional pre-bid conference will be held on September 3, 2025 at 10:00 AM, local time in the Port Conference Room at City Hall located at 44 N. Lorimier St., Cape Girardeau, MO 63701.

The City of Cape Girardeau hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Bidder must be pre-qualified by MoDOT in accordance with Sec 102.2 of the Missouri Standard Specifications for Highway Construction.

The prime contractor must perform, with its own staff, contract work amounting to NOT less than 30% of the total original contract price.

The project will be awarded to the lowest, responsive, responsible bidder. The Owner reserves the right to waive all informalities not involving price, time or changes in Work and to negotiate contract terms with the Successful Bidder.

Plans, specifications, proposal form, and contract for said improvement may be viewed and/or obtained from the City's website at: www.cityofcape.org/bids. Paper bid submittals will be required for this project.

All wages paid for work under this Contract shall comply with requirements of the prevailing wage law of the State of Missouri, Sec. 290.210 through 290.340, R.S. Mo. 1978, as amended. Bidders must agree to comply with all statutory regulations referred to in the specifications. Weekly certified payrolls will be required from the General Contractor and Subcontractors.

Pursuant to 285.530 R.S. Mo, the bidder must affirm its enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the services requested herein.

Additionally, pursuant to 292.675, R.S. Mo, the bidder is informed that all contractors or subcontractors doing work on this project to provide, and require its on-site employees to complete, a ten (10) hour course in construction safety and health approved by the Occupational Safety and Health Administration ("OSHA") or similar program.
