up about 11% through April 2024 when compared to the same time last year.

MoDOT/MSHP Prescription Drug Paid Claims Monthly Comparison (2022/2023) -

Mr. Denkler reported that Plan paid costs are up 5.3% through April 2024, when

compared to the same time last year.

Anthem 1st Quarter Review – Mr. Denkler welcomed Anthem Staff to the meeting.

Anthem reported a 18% increase in medical paid per member per month spend, from the

prior reporting period. The current medical paid per member per month is \$334.56.

Telehealth Visits increased but are still well below the benchmark.

PillarRx 1st Quarter Review – Mr. Denkler welcomed PillarRx staff to the meeting.

PillarRx reported they are finalizing the data for the Pharmacy bidders and that

everything remains on track for next month's meeting.
