Markers shall be placed over existing runway numerals; however, when work is necessary for that area or if numerals intersect an active runway or taxiway, the markers shall be relocated 80' off of the edge of pavement as shown on the detail. This relocation is temporary, the contractor shall return the markers to the preferred location as soon as possible following completion of work in that area.
