### **Route I-70 in St. Charles County.**

The proposed improvement provides grading, drainage, retaining walls, signals, signing, lighting, and paving to construct a new eastbound one-way south outer road between Woodlawn Avenue and Route K. The project also involves converting the existing north outer road from a two-way to a one-way westbound outer road between School Road and Woodlawn Ave., and revising the eastbound off ramp to Route K. Also, U-Turn ramps will be constructed on the Woodlawn Overpass and under the I-70 bridge over Route K. Additional improvements will be made on Crestview Drive and on Woodlawn Avenue between West Terra and Crestview Drive.
