Dear Consultant:

Missouri's Local Program representatives request the services of consulting firms to perform on-call professional services as described on the following pages. This solicitation is for Missouri's Local Program (LPA) and **not for MoDOT** on-call services. A list of prequalified consultants will be created from this solicitation for LPA's to choose from for projects that fit the requirements of each category with a \$100,000 limit, as detailed in MoDOT's LPA manual [Section 136.4.2.4.3](#).

To be considered for these LPA consulting services, you may express your interest by responding **via email** to the MoDOT Central Office - Local Program Administrator, as indicated on the following pages. Your firm must submit separate letters of interest for each work category accompanied by the cover sheet for each work category provided on the following pages. The letter of interest should contain any information which might help us in the selection process, including why your firm is qualified to provide the services. Limit the letter of interest to no more than three pages plus the cover sheet. Please submit your company brochure and/or marketing materials to be shared with the LPAs; this material will be limited to 4 pages. Your company information will not count as the letter of interest page limit. A page is defined as one side of 8 1/2" x 11" sheet of paper. Listed below are the submittal requirements in electronic format:

- Cover Sheet for each category
- Letter of interest for each category (3 page max per LOI)
- 3 Company Reference Forms for each category
- Company Brochure (4 page max)
- Submittal documents must be submitted in minimum 11 point font

We encourage DBE firms to submit letters of interest for categories in which they are qualified. DBE firms must be certified by the Missouri Department of Transportation.

A consulting engineering firm under contract to serve as the city engineer to provide oversight of engineering functions and the work of engineering consultants procured by the city will not be allowed to perform engineering work for the city for which they are city engineer. A potential conflict of interest would arise if the consulting firm were awarded the project-related design services.

Missouri's Local Program Advisory Committee together with MoDOT will evaluate firms based on: General Experience of Firm, Past Performance, Qualifications of Personnel, Familiarity/Capability, and Accessibility. The scoring criteria weighted values are indicated on the following pages. Firms not current on all of the required LPA prequalification categories found in [MoDOT's Approved Consultant Prequalification List](#) at the date of the solicitation expiration will be considered non-responsive. Firms not submitting the required three company reference forms per category will be considered non-responsive.

All letters must be received by 3:00 pm, December 13, 2019 via email. Only those letters of interest received by the deadline will be considered.

The following pages outline additional information. Please note, selection of your firm for the LPA On-Call Consultant List does not guarantee work.

WORK CATEGORY DESCRIPTIONS

Please note: All design related work that may result from this solicitation must conform to standards set forth by the local agency and meet the requirements of State and Federal Law.

Roadway Design

This category of work is defined as the development of competently engineered highway plans and related design studies. The work generally includes widening, resurfacing, pavement reconstruction, utility design and coordination, right of way, environmental clearance, traffic signals and lighting, general lighting, surveying, sidewalks and trails (as part of a roadway design contract), and parking lot design but may include other work as related to roadway design.

Trails & Sidewalks

This category of work is defined as the production of competently engineered trail and pedestrian use facilities, environmental clearance, right of way, signal and lighting, landscaping and beautification but may include other work as related to trail and sidewalk design. Landscape Architects will be eligible for consideration in this category.

Construction Inspection

This category of work is defined as managing, documenting and inspecting projects associated with the construction of a new and/or modified existing facility. The work may involve the identification and resolution of issues relating to materials, work, progress, change orders and disputes. It may also include geotechnical work, sampling and testing, attending construction related meetings and reviewing shop drawings, but may also include other work related to construction inspection.

Traffic Engineering & TEAP

Traffic Engineering in this category is defined as design of improvements intended to relieve traffic problems, such as signalization, signing, lighting and pavement markings. Traffic Engineering Assistance Program (TEAP) in this category is defined as studies that may include corridor safety and/or operational analysis, intersection(s) safety and/or operational analysis, speed limit review, sign inventory, pedestrian/bike route analysis, parking issues, and other traffic studies (See EPG 136.3.8.10 for further guidance on TEAP)

Structures

This category of work is defined as the production of competently engineered structural plans. The work generally includes plans development, detailing, hydraulic studies, geotechnical work, survey, cost comparisons, environmental clearances, right of way and may include other work related to bridge design.



WORK CATEGORY DESCRIPTIONS Continued

Environmental

This category of work is defined as the preparation of Categorical Exclusion, Environmental Assessment, and Environmental Impact Statement documents, and re-evaluations of documents in compliance with all requirements of the National Environmental Policy Act (NEPA) under FHWA procedures. Additionally, this category of work will include performance of field surveys for wetlands, streams, hazardous waste, and other specialties. It will require specialized species surveys, habitat assessments, and analysis to support a determination of impact to listed species and protected resources, including reports of those surveys. Other work will include floodplain, farmland, socioeconomic impacts, noise analysis, which will consist of, but is not limited to noise monitoring, modeling, and the preparation of noise reports.

Historic Preservation

This category of work is defined as providing compliance with Section 106 of the National Historic Preservation Act, which requires conducting background investigations, Phase I surveys, Phase II National Register evaluations, Phase III adverse effects mitigation (e.g. archeological data recovery, documentation of historic bridges and buildings etc.), and other various tasks as related to cultural resources.

SCORING CRITERIA DEFINITIONS

Prequalification – Firm must be listed on MoDOT’s Approved Consultant Prequalification List prior to this solicitation expiration date.

3 Company Reference Forms – The firm must get 3 Company Reference Forms filled out by 3 separate LPAs for each category they are interested in. Reference Forms are allowed from the same LPA as long as the forms are for different projects and have different project managers. The form is attached to this solicitation. Please include information such as Job Number, year the project was designed and personnel involved in the project. The entity responsible for rating the firm on the Reference Form should sign the form, not the consulting firm.

General Experience of Firm – The consulting firm will be evaluated for experience on similar and related type work it has performed. This information should be included in the firms Letter of Interest (LOI). The firm will also be evaluated on years of experience performing this type of service along with feedback from references.

Past Performance – The consulting firm will be evaluated on their past performance on similar projects for cities, counties, MPO’s and other entities. The firm must indicate if past projects were federally or locally funded. Consideration will be given to feedback from references and the quality of past work.

Qualifications of Personnel – The consulting firm will be evaluated based on the qualifications of employees in the firm. Consideration will be given to extensive experience in the particular type of work.

Familiarity/Capability – The consulting firm will be evaluated on the firms familiarity with federal projects and ability to deliver federal projects compliant with federal law.

Accessibility – Priority is given to firms with a previously established record of responsiveness to their clients’ needs.
