St. Louis County Project No. AR-1565, Federal Project No. STP-4956(604) consists of resurfacing, full depth pavement repairs, pavement widening, upgrading curb ramps, sidewalk and curb repairs, overhead signing and foundations, and upgrading traffic signals on Lackland Road from east of Craig Road to east of Concourse Drive within St. Louis County and other incidental items necessary to complete the above in a workmanlike manner.

Contractors and sub-contractors who sign a contract to work on a public works project shall provide a ten (10) hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
