Sealed bids for St Martins Business 50W Bicycle/Pedestrian & ADA Improvements & Resurfacing street Paving, Project No. TAP-9901(523), will be received at City of St Martins, City Clerk, 6909A Business 50West St Martins, Missouri until 12:00 o'clock P.M. (Prevailing Local Time) on the **February 13, 2024**, bids will be publicly opened and read at 1:00 P.M. Bids should be delivered to: City Clerk, City of St Martins, 6909A Business 50W, St Martins, MO, 65109.

The proposed work includes: TAP 9901(523) - Grading, paving, and shoulder widening to provide pedestrian and bicycle facilities from just west of Carel Rd. to Henwick Lane on Business Route 50 West in St. Martins.  
and

G15950 – B - Resurfacing and pavement marking from just west of Carel Rd. to Henwick Lane on Business Route 50 West in St. Martins.

The projects listed above shall be bid in required combination. Combination bids will be in accordance with Sec. 102.12. By signing this bid, the bidder agrees to combine all projects in accordance with 102.12.1.

A pre-bid conference will be held at 10:00 o'clock A.M on **January 31 , 2024**, at the City of St. Martins, 6909A Business 50W, St Martins, Mo. 65109. All bidders are encouraged to attend the pre-bid meeting.

**All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.**

The City of St. Martins hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

All bidders must be on MoDOT’s Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10- Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The project will be awarded to the lowest, responsive, responsible bidder. The City of St. Martins reserves the right to reject any or all bids.

**The DBE Goal for this project is 4%.**

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
