

The Missouri Department of Transportation is proposing to amend the state's five-year Statewide Transportation Improvement Program (STIP).

A 7-day public comment period regarding the Administrative Amendment begins January 1, 2026 and ends January 7, 2026. The proposed January Administrative Amendment is attached below.
