

Pavement, Intersection, and Sidewalk (ADA) Improvements in Audrain County



Project Summary

The Missouri Department of Transportation (MoDOT), working with its consultant Bartlett & West, is preparing for a future project that will include resurfacing and sidewalk improvements at various locations on Business 54, Route J, Liberty Street, Missouri Route 15 and Missouri Route 22 in Mexico. Sidewalk improvements are being completed as part of MoDOT's initiative to bring all MoDOT facilities into compliance with the current standards of the American's with Disabilities Act (ADA).

Project Purpose and Need

The resurfacing and sidewalk improvements on Business 54, Route J, Liberty Street, Missouri Route 15 and Missouri Route 22 located in Mexico, it to enhance roadway safety, improve ride quality, and provide accessible pedestrian facilities in compliance with the current standards of the American's with Disabilities Act (ADA).

Frequently Asked Questions

Q: How much does the project cost?

A: Approximately \$4 million

Q: What are the anticipated impacts?

A: Construction details have not been finalized at this time. MoDOT will work with residents and business owners to ensure access is available during construction.

Q: Will the road be closed during construction?

A: Various traffic impacts will be in place as the project progresses. MoDOT will make every reasonable effort to reduce delays due to construction. Customers can anticipate temporary traffic impacts throughout the project. More information regarding traffic impacts will be shared through news releases and social media for each stage of construction as details become available.

Q: Will MoDOT need to acquire any right of way?

A: Yes. In 2025, MoDOT's Right of Way staff and consultants will begin the process of contacting property owners for any necessary right of way needed for the project. Right of way discussions are anticipated to continue through 2026.
