

Adding a Power Unit to a Haz Waste Transporters License External Procedure

You can add or replace a vehicle during the license period. Vehicles can be removed from a license ONLY during the renewal process.

1. Access MoDOT Carrier Express (MCE) through the log in page located at www.modot.org/mce. Enter the user id and password assigned to you by Motor Carrier Services and click log in.


