- Subcommittee Meeting: from 1:00-1:30 p.m. the subcommittees met and discussed funding, boundaries, goals, outreach and recruitment, and scheduling future meetings.
- Call to Order: Chance Gallagher called the meeting to order at 1:27pm.
- Approval of Minutes: Amanda Cullin moved to approve the November 15, 2022, meeting minutes. Max Scheiber seconded the motion and it passed unanimously.
- Budget Update: Jenna Keyes provided a review of the budget which is attached to the end of these minutes. Larry Stobbs inquired about purchasing shirts for university events.
- Statewide Fatality totals: Chance Gallagher reported on the Statewide Fatality totals
 which are nearing the end of the year. Jenna Keyes presented the Show Me Zero statistics
 show that Atchison, Mercer, Sullivan, Grundy, Carroll, and Caldwell Counties all went
 through 2022 without a fatality. She plans to wait until February for final calculations to
 do press releases and award presentations. Sullivan County has requested to share social
 media posts through their pages.
- Subcommittees Reports: a list of subcommittee members is attached to the end of these
 minutes.
 - Occupant Protection
 - Amanda Cullin reported that they discussed the helmet law, as the current rule states, a rider must be 25 years or older to determine if they do not wish to wear a helmet, but that makes it difficult to enforce, so they are

hoping to do a campaign to raise awareness, perhaps through the university if that is a possibility. Jenna Keyes discussed the contracting process.

Distracted Driving

- Chris McBane reported that the Distracted Driving Committee has not met but hopes to before the March meeting
- Speed and Aggressive Driving
 - Trenny Wilson reported that the Speed and Aggressive Driving
 Committee has not met yet
- Impaired Driving
 - Larry Stobbs and Shane Hux met prior to the coalition meeting and discussed lack of rural officer safety support and the potential to purchase traffic cones to block off scenes and redirect traffic.

• Upcoming Events

- O Jenna Keyes discussed MCRS Strategic Advance, a new project through MoDOT inviting 4-5 strong members from each coalition to join March 8-9 in Jefferson City and brainstorm together. There is likely funding in the conference budget to send local representatives, so if anyone is interested, let Jenna know.
- O Michael Davis announced that they just finished their Holiday Impaired Driving Campaign. The next will be Spring Impaired Driving from March 17-19. There will be a Seat Belt Enforcement Campaign April 15-16. Mothers Against Drunk Driving will be having a free day long summit at the Kansas City Missouri Police Academy on March 22. Annual Grant Application meetings are Thursday in Lee's Summit and Friday in Jefferson City.
- O Jenna Keyes discussed current safety legislation updates and the new Buckle Up Phone Down Business Showdown. There are currently five bills filed for a handsfree law and expected bills for ignition interlock and rear facing car seats. Jenna discussed contracts are being sent out for the grant agreements and that reimbursement requests should be sent in to Melanie Noel. Community grant still has quite a bit of funding available so we should do a press release for schools to start thinking about applying.
