

INVITATION TO BID

Sealed bids for the **South Creek Greenway (Fremont to Glenstone), Federal Project CRP-5901(830) and South Creek Greenway (Sunset/Glenstone Crossing), Federal Project CRP-5901(839)** will be accepted at the City of Springfield, Busch Building, 840 Boonville, Springfield, MO 65802 until 10:30 a.m. **on Thursday September 3, 2026** and then publicly opened and read aloud in the 2nd floor East Conference room of the Busch Building. Bids received after 10:30 a.m. will be returned unopened.

Required Combination

1.0 The following projects are in required combination and bids shall be submitted for all listed projects. If bids are not submitted for all projects listed below, the bids will be considered irregular.

2.0 The combination of the total prices of the base bids for all projects listed in section 1.0 will be used to determine the low bid. **See Job Special Provision 01.02 Award of Contract and Submittal Requirements** for further information on the basis of award.

Project CRP-5901(830) consists of constructing a multi-use path along the south side of Sunset Street from Fremont Avenue to Glenstone Avenue and replacement of the traffic signal at the intersection of Sunset Street and the Battlefield Mall Access Drive. Main elements of work include: approximately 22,500 SF of Concrete Sidewalk, approx. 400 SF of Concrete ADA Ramp, approx. 2,300 SF of Concrete Driveway (Commercial), approx. 770 linear feet of Curb and Gutter, fiber extension items, and signal improvement items.

Project CRP-5901(839) consists of constructing pedestrian crossings at the intersection of Sunset Street and Glenstone Avenue, making a connection to the CRP 5901(830) project, connecting to existing MoDOT/City sidewalk on the east side of the intersection, extending a sidewalk along the West side of Glenstone Avenue to a City Utilities bus stop south of Sunset Street, pedestrian signal improvements, and associated stormwater improvements. Main elements of work include: approximately 250 SY of Concrete Sidewalk, approx. 85 SY of Concrete Curb Ramp, approx. 290 LF of Concrete Gutter (TYPE B), associated stormwater improvements, fiber extension items, and signal improvement items.

Pre-bid Conference/Site Investigation: A pre-bid conference will be held at 2:00 p.m. on Thursday August 20, 2026, in the 2nd floor East Conference Room of the Busch Building. **All Bidders are encouraged to review the work site and attend the Pre-bid Conference.**

A certified or cashier's check or bid bond in the amount of 5 percent of the bid shall be submitted with each proposal. Note all labor shall be paid Missouri Prevailing Wages and/or Federal Davis-Bacon Wages, whichever is higher. The City reserves the right to reject any and all bids and to waive irregularities in bids.

Bidders must be on the MoDOT's Qualified Contractor List per section 102.2 of the Missouri Standard Specifications for Highway Construction, current version including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on this project must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees.

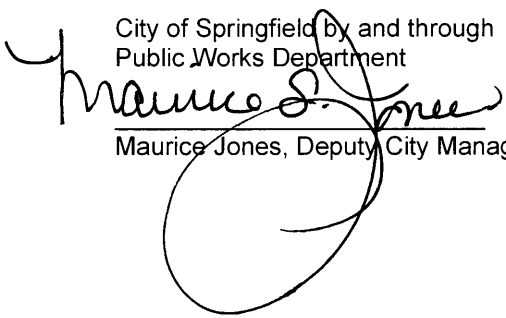
