INVITATION TO BID

Date: December 17, 2015

Sealed Bids will be received by the City of Cameron, Missouri (Owner) at the office of the City Clerk at City Hall, 205 N. Main Street, Cameron, Missouri 64429, until **10:00 am**, local time, **Thursday, January 28, 2016** for Walnut Street Sidewalk, Baldwin Street to Bryan Road, MoDOT STP-7000(105) and, in required combination, Walnut Street Sidewalk, Grand Avenue to Baldwin Street MoDOT STP-7000(106).

At said place and time, and promptly thereafter, all Bids that have been duly received will be publicly opened and read aloud.

The proposed Work is generally described as follows:

This project is a combination of two projects that are separate only for administrative purposes. The successful bidder shall complete this proposed Work as a single project in terms of scheduling and execution. Note that this project is a rebid of the two separate projects. The City has increased their budget and combined the projects for this bid.

7000(105): Construction of bridge barrier, cantilevered sidewalk, curb and gutters, sidewalks, retaining walls, traffic signal upgrades, decorative pedestrian fence, and ADA ramps. Work also includes associated street work and all appurtenant work as indicated in the Contract Documents. The project is generally located at Walnut Street Sidewalk, Baldwin Street to Bryan Road.

7000(106): Construction of curb and gutters, sidewalks, entrances, retaining walls, underground storm drainage and ADA ramps. Work also includes associated street work and all appurtenant work as indicated in the Contract Documents. The project is generally located at Walnut Street Sidewalk, Grand Avenue to Baldwin Street.

Bidding

Each bidder shall furnish with the bid satisfactory evidence of Bidder's competency to perform the proposed work. Such evidence of competency shall consist of the following:

MoDOT STP 7000(105) & MoDOT STP 7000(106)
Walnut Street Sidewalk, Baldwin Street to Bryan Road and Grand Avenue to Baldwin Street

- a. Experience Reference Summary for similar projects performed with the past 5 years including reference information.
- b. Statement that Bidder is current on payment of Federal and State income tax withholdings and unemployment insurance payments.
- c. Statement of Bidder's litigation and/or arbitration history over the past five (5) years including final ruling.
- d. Statement of Bidder's bond history over the past five (5) years including any incidences of failure to perform.

Bids will be received on a unit price basis.

The Successful Bidder will be required to furnish a Construction Performance Bond, a Payment Bond, and a Maintenance Bond as security for the faithful performance and the payment of all bills and obligations arising from the performance of the Contract.

Each proposal shall be accompanied by a Bid Bond drawn on an acceptable bank, made payable, without condition, to the City of Cameron, Missouri, in an amount of not less than **5 percent** of the total proposal cost.

Non-resident corporations that are not already registered, and all non-resident individuals and partnerships are required by law to register with the Missouri Department of Revenue.

No proposal may be withdrawn within a period of 30 days from and after the date fixed for opening proposals. If the Contract is to be awarded, Owner will give the Successful Bidder a Notice of Award within the number of days set forth in the Bid Form for acceptance of the Bid.

The City of Cameron hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The City reserves the right to reject any or all proposals, and to waive any informalities or irregularities therein.

The DBE Goal for the 7000(105) project is 10%.

The DBE Goal for the 7000(106) project is 7%.
