We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm's Statement of Qualifications (RSMo8.285 through 8.291) and an Affidavit of Compliance with the federal work authorization program along with a copy of your firm's E-Verify Memorandum of Understanding (15 CSR 60-15020) be submitted with your firm's Letter of Interest.

We request all responses be received by 3:00pm CST October 30, 2019 at the City of Fenton City Hall, 625 New Smizer Mill Rd. Fenton, MO 63026.
