The City of St. Robert is requesting the services of an engineering consulting firm to perform reconstruction and permanent signalization of the intersection of the St Robert Outer Road and Highway Y. The described professional services for the project are listed under "Consultant Services Required" on the attached list. If your firm would like to be considered for these engineering consulting services, you may express your interest by responding to the appointed contact person, or Mayor, City of St. Robert, which is indicated on the attachment. Limit your letter of interest to no more than two (2) pages. This letter should include any information which might help us in the selection process, such as the persons or team you would assign to each project, the similar project backgrounds of those individuals, and other projects your company has recently completed or are now active. It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) be submitted with your firm's Letter of Interest, or be on file with MoDOT as part of the pre-qualification documents. The statement of qualification is not included in the total page count limit.

DBE firms must be listed in the MRCC DBE Directory located on MoDOT's website at [www.modot.gov](http://www.modot.gov), in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in [MoDOT's Approved Consultant Prequalification List](#), or your firm will be considered non-responsive.

We request all letters be received by 1:30 pm, April 30th at City Hall: 194 Eastlawn Ave, St. Robert, MO 65584.
