Camden County – Willow Creek Road Bridge Improvements
Federal Aid Project No. BRO-B0-15(001)

Located along Willow Creek Road over the South Fork of Linn Creek in Camden County, Missouri.

Bids will be received and opened publicly at the office of the Camden County Clerk's Office, 1 Court Circle, NW Suite 2 Camdenton, MO 65020 at, **10:00 A.M. on 3rd of February, 2022.**

Any and all bids received after the time specified above will be returned unopened.

The proposed work involves replacing the Willow Creek Road vehicular-bridge crossing at the South Fork of Linn Creek with a single-span bridge 24' in width and will utilize MODOT type II girders anticipated to be raised a foot. The current wall abutment will be removed, and will be replaced with a spill-slope style bridge (2' rock blanket) with an end bent supported by piles. All equipment, material and workmanship must be in accordance with the plans, specifications, and contract documents on file with Camden County.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Camden County hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2017 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

CONTRACT DOCUMENTS may be examined at the Camden County Clerk's Office, 1 Court Circle, NW Suite 2 Camdenton, MO 65020. Bidding documents will be shipped only if the requesting party assumes responsibility for all related charges. Corporate, certified, or cashier's checks shall be made payable to ADS.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

Camden County reserves the right to reject any or all bids.

Proposals must be on forms provided.

The project will be awarded to the lowest, responsive, responsible bidder.

No 2nd tier subcontracting will be allowed on this project.
