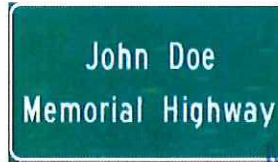

Born December 24, 1946, Campbell grew up on a farm outside of Russellville. He was drafted into the US Marine Corp in 1966.

He was deployed to Vietnam in Sept. 1966 as a rifleman. On August 13, 1967 he was killed by an unknown explosive devise.
