Overview

Updating the profile to reflect a change or correction of the address, legal name and/or Tax ID.

Documents Required

If carrier has IRP:


- New title required if the unit needs to be retitled in the new business name. E.g., company changes from an LLC to an INC. A new title will need to be applied for since the LLC no longer exists.
- Lease will be needed if vehicle is owned by anything other than the new name.

A processing agent will contact you if documents are required. The documents will need to be emailed to Contactmcs@modot.mo.gov
