Each proposal must be accompanied by a bid guaranty in the form of a Bid Bond or certified check in the amount of five percent of the total amount of the bid. The bid guaranty shall be payable to the County of New Madrid, Missouri.

**Prevailing Wages:** The City shall cause to be inserted in the Contract a stipulation to the effect that not less than the prevailing hourly rate of wages, as found by the Missouri Division of Labor Standards (hereinafter “prevailing hourly wage rate”), shall be paid to all workers performing work under the contract. The Contractor’s bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as set forth in the contract.

This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise Participation. The Owner has established a contract goal of **0.0** percent participation for small business concerns owned and controlled by qualified disadvantaged business enterprises (DBE). The Bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet the established goal.
