REVISE the second sentence in Section 101-5.1 to read as follows: "This price shall be full compensation for removal of the Portland cement concrete and underlying aggregate base down to the existing subgrade, furnishing all materials and for all preparation, hauling, and placing of the material and for all labor, equipment, tools, and incidentals necessary to complete this item."
