The City of Eureka, Missouri is seeking sealed bids for the following:

Allenton Road Improvements Project, STP-4901 (644) The project is generally located along Allenton Road at Business Loop 44 in Eureka, Missouri.

Notice to Contractors

Sealed bids for Allenton Road Improvements Federal Project No. STP-4901 (644) will be received at: 111 N. Virginia Avenue, Eureka, MO 63025 until 12:30 P.M. (Prevailing Local Time) on the 30th day of July, at the office of the City Clerk. The sealed bids will be publicly opened and read at 1:00 P.M. (Prevailing Local Time) on the 30th day of July at the Timbers of Eureka Recreation Center, 1 Coffey Park Lane, Eureka, MO 63025. All bids shall be submitted in the form of sealed envelope addressed to the City of Eureka, Missouri.

The proposed work includes: Grading, Paving, Drainage, Traffic Signals, Sidewalk, Signing, Widening, Bridge, ITS and Lighting.

Bidders are required to provide their contact information on our "Request for Proposals & Qualifications" webpage to be able to download the PDFs. The contact information will be used to generate a plan holders list to distribute addendum notifications (if needed). A pre-bid conference will be held at 1:00 P.M. on the 9th day of July, at The Timbers of Eureka Recreation Center, 1 Coffey Park Lane, Eureka, MO 63025. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or State Wage Rate, whichever is higher.

The City of Eureka, MO hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file seven (7) days prior to bid opening.

Contractors and subcontractors who sign a contract to work on public works project provide a 10-Hour OSHA April 2024

construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

Bids will be received on a unit price basis. **The project will be awarded to the lowest, responsive, responsible bidder.** The City of Eureka, Missouri reserves the right to reject any or all bids.

The DBE Goal for this project is **10%**.

No 2nd tier subcontracting will be allowed on this project.
