## OPEN SESSION

The meeting was called to order at 7:59 a.m.

Mr. Schwartze motioned to approve the Consent Agenda items with amended changes to the consent items. Mr. Reeser seconded; motion carried.

Aetna Claims Summary (2016/2017) – Mr. Padgett reported Plan medical claim payouts have increased 16% when compared to 2017 through the first month of the 2018 calendar year.

MoDOT/MSHP Prescription Drug Paid Claims Monthly Comparison (2016/2017) - Mr. Padgett reported Plan prescription claims costs have increased 13% when compared to 2017 through the first month of the 2018 calendar year.

<u>Update of Life Insurance Audit</u> Ms. Halford updated the Board on the life insurance audit. The audit came back successful. We did determine there were three members whose life insurance coverage amount did not decrease to \$60,000 at age 62. Those member's were corrected and refunded premium overpayments.

**AON Hewitt 2017 Annual Evaluation** Mr. Padgett welcomed AON Hewitt staff to the Board meeting.

<u>Semiannual Review-</u> Ms. Huber presented to the Board the key findings for calendar year ending December 31, 2017. The recommended IBNR is \$13.2 million, which is an decrease of \$3.2 million when compared to CY 2016. The ultimate incurred claim liability for CY 2017 has increased 0.7% per employee over CY 2016. Paid medical claims for CY2017 increased 11.7% PEPM, while paid prescription drug claims decreased 2.1% PEPM over CY2016.

GASB Accounting- Mr. Witte presented to the Board the Post-Retirement Medical Benefit GASB Accounting report. Government entities offering subsidized postretirement medical benefits are required to accrue for these benefits during the working careers of participants. The goal is to fully account for these employment related costs (benefits earned during the career) by

retirement. The total OPEB liability for the Plan is \$1.2B.

MedImpact 4<sup>th</sup> Quarter Update- Ms. Babcock and Ms. Buchringer reviewed the 4th quarter report package with the Board. Fourth quarter 2017 vs fourth quarter 2016 showed a decrease in the number of claims, but an increase in the total claim cost. Though our numbers are up, we stack up extremely well against the benchmarks. The Board asked if the specialty direct program has been reviewed recently. It was reviewed in August, and still showed a very minimal savings.

Other Business- None.
