We understand that failure of our product to meet specifications or our failure to comply with MoDOT's requirements regarding procedure or documentation may result in removal from the PAL for a period of not less than one year. We recognize that removal from the PAL may also occur if unacceptable field performance occurs, even if the unacceptable performance is due to inappropriate handling, storage or use by the Contractor or the Contractor's assignees.

- 1) A full description of the material (a list of materials including size and grade for applicable facility approval), how material will be identified, and the applicable specification(s) being met.
