13 **Contract Documents.** The complete set of Specifications and Contract Documents can be downloaded from
14 Jviation, Inc.'s bid site (<http://bid.jviation.com>), beginning on January 11th, 2022. In order to submit a
15 responsive bid as a Prime Contractor and to receive all necessary addendum(s) for this project, you must be on
16 the Planholder's List. To view all planholder documents (contract documents, plans and addendums) you must
17 fill out the online form located at (<https://jviation.com/bid-request>). By filling out and submitting this form,
18 you agree to be publicly listed on the bid site with your contact information as a planholder for all projects
19 requested. **It is the planholder's responsibility to review the site for addendums and changes before**
20 **submitting their proposal. This includes review for environmental changes. Environmental changes**
21 **during construction could take up to four weeks for approval.** For additional information, please contact

29 **Pre-Bid Conference.** The pre-bid conference for this project will be held on Thursday, January 27th, 2022 at
30 2:00 p.m., at 6079 County Road 425, Hannibal, MO 63401 - Airport Conference Room. All bidders are required
31 to examine the site to become familiar with all site conditions.

33 **Bid Conditions.** The bidder is required to provide all information as required within the Contract Documents.
34 The bidder is required to bid on all items of every schedule or as otherwise detailed in the Instructions to
35 Bidders.

37 Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount
38 of the bid. The bid guaranty may be by certified check or bid bond made payable to City of Hannibal.

40 Bids may be held by City of Hannibal for a period not to exceed 120 calendar days from the date of the bid
41 opening for the purpose of evaluating bids prior to award of contract.
42

43 The right is reserved, as City of Hannibal may require, to reject any and all bids and to waive any informality in
44 the bids received.

46 Construction for this project is expected to take 30 Calendar Day(s).
47

48 In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required
49 to comply with the wage and labor requirements and to pay minimum wages in accordance with the schedule
50 of wage rates established by the United States Department of Labor and the Missouri Division of Labor
51 Standards, respectively. The highest rate between the two (Federal and State) for each job classification shall be
52 considered the prevailing wage.

54 **Equal Employment Opportunity and Affirmative Action Requirement.** The proposed contract is under
55 and subject to 41 CFR Part 60-4 and Executive Order 11246 of September 24, 1965, as amended, and to the
56 equal opportunity clause and the Standard Federal Equal Employment Opportunity Construction Contract
57 specifications including the goals and timetables for minority and female participation.

59 **Title VI Solicitation Notice:** The City of Hannibal, in accordance with the provisions of Title VI of the Civil
60 Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders
61 that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged
62 business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and
63 will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

66 **Information submitted as a matter of bidder responsibility:**

67 The Owner's award of this contract is conditioned upon Bidder or Offeror satisfying the good faith effort
68 requirements of 49 CFR §26.53.

69 The successful Bidder or Offeror must provide written confirmation of participation from each of the DBE
70 firms the Bidder or Offeror lists in its commitment within five days after bid opening.

- 71 1) The names and addresses of Disadvantaged Business Enterprise (DBE) firms that will participate in
72 the contract;
- 73 2) A description of the work that each DBE firm will perform;
- 74 3) The dollar amount of the participation of each DBE firm listed under (1)
- 75 4) Written statement from Bidder or Offeror that attests their commitment to use the DBE firm(s)
76 listed under (1) to meet the Owner's project goal; and
- 77 5) If Bidder or Offeror cannot meet the advertised project DBE goal, evidence of good faith efforts
78 undertaken by the Bidder or Offeror as described in appendix A to 49 CFR part 26.

80 The requirements of 49 CFR part 26 apply to this contract. It is the policy of the City of Hannibal to
81 practice nondiscrimination based on race, color, sex or national origin in the award or performance of this
82 contract. The Owner encourages participation by all firms qualifying under this solicitation regardless of
83 business size or ownership.
