# **Improve I-70 Traffic Operations and Safety Lead**

The Missouri Department of Transportation is seeking a Traffic Operations and Safety Lead for the planning, coordinating, managing all traffic engineering issues including traffic control devices, plans, signing, marking, signals, lighting, permits, work zones, incident management, intelligent transportation system of the statewide Improve I-70 Program. This program includes the planning, design, construction, reconstruction, rehabilitation, and repair of three lanes in each direction on approximately 200 miles of I-70.

The Traffic Operations and Safety Lead will provide oversight for the program's traffic field operations and engineering activities; reviews and approves complex or controversial traffic studies; provides direction on development of the program's arterial management system. Expected duties include developing the MoDOT Program Team, supervising preparation of program documentation; providing technical expertise and design/constructability input; and resolving ongoing program issues; as well as identify safety needs and recommend improvements. The Traffic Operations and Safety Lead has direct responsibility for the success of the program and supervises staff assigned to the MoDOT Program Team along with owner engineer consultant activities.

- Bachelor's Degree: Civil Engineering from an ABET-accredited college or university curriculum.
- Licensed as a Professional Engineer in the State of Missouri.
- Nine years of progressive experience in engineering positions, including demonstrated ability to manage teams, multiple projects, and focus on several functional areas of engineering.
