and endorsed "Proposal" for construction of **Federal Aid Project No. TAP-9900(790), 5th Street Pedestrian Bridge Over Flat Creek** will be received by the City until **10:30 A.M., September 25, 2025 Local Time** at the office of the City of Cassville located at 300 Main Street, Cassville, Missouri 65625, and at that time will be publicly opened and read aloud.

Project Description: The project will consist of the construction of a new, approximately 220-foot long prefabricated truss bridge with a 10-foot wide pedestrian walkway, including embankment, rip rap, excavation and vegetative restoration together with any incidental work to the pedestrian walkway and existing stormwater system.
