The Missouri Highways and Transportation Commission is requesting services of consulting engineering firms to perform the described professional services for multiple projects as shown on the attached list. Clearly indicate what project packages your letter of interest represents on the required Cover Sheet. The projects can be awarded to any number of proposers or one proposer. \*A page will be considered one side of an 8.5”x 11” size sheet of paper.

Please clearly indicate in the provided Cover Sheet for which project(s) your consultant team is interested.

Page 2 and 3 of the submittal should include any company information, which might help in the selection process, including general experience of the firm, familiarity/capability, accessibility of firm and staff, past performance, qualifications and backgrounds of key personnel you would assign to the project. An explanation of your firm’s approach to promoting and developing a diverse workforce. MoDOT is committed to reflecting the diversity of the communities we serve, and we expect our partners to do the same

The last two (three for J4I3458) pages per project should include a statement to indicate your firm’s understanding of the project and any innovative approaches to be utilized during project development. It should also include any other information which might help us in the selection including the key personnel you would assign to the project. These pages should also identify any sub-consultants you would propose to use. In addition, please include detailed information on similar projects that your key personnel have worked on. Indicate the role your key personnel played in the projects and include reference contact information. Any consultant or sub-consultant which qualifies as a DBE should be indicated.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm. We also encourage both DBE firms and non-DBE firms to consider joining MoDOT's Mentor/Protégé program whenever possible as part of a MoDOT project.

We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information.

Firms that are not current on all of the required prequalification categories found in MoDOT's *Approved Consultant Prequalification List* at the date of the solicitation expiration will be considered non-responsive.

Interviews/presentations will not be required for the consultant selections. Additional information files are located on the MoDOT solicitation website.

**An optional informational meeting is scheduled for September 5, 2023, 1:00 p.m. to 2:30 p.m. at the MoDOT District Office (600 NE Colbern Rd, Lee's Summit, MO 64056) in room 252.** A brief presentation will be made on each project, followed by a question and answer period. **Interested firms are encouraged to attend the informational meeting as no individual meetings with consultants will be held.** Project managers will accept phone calls to answer questions.
