Limit your letter of interest to no more than three pages. This letter should include a statement to indicate your firm's understanding of the project. It should also include any other information which might help us in the selection process, including key personnel you would assign to the project and the backgrounds of those individuals, and any sub-consultants you would propose to use, and an indication of your firm's approach to promoting and developing a diverse workforce. MoDOT is committed to reflecting the diversity of the communities we serve and we expect our partners to do the same. We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information. In addition, please attach one page with detailed information on similar projects that your key personnel have worked on. Indicate the role your key personnel played in the projects and include reference contact information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm. We also encourage both DBE firms and non-DBE firms to consider joining MoDOT's Mentor/Protégé program whenever possible as part of a MoDOT project.

MoDOT will evaluate firms based on: Project Understanding & Innovation, Past Performance, Qualifications of Personnel Assigned, General Experience of Firm, Familiarity/Capability, Accessibility of Firm & Staff. Firm's not providing a response on approach to workforce diversity will be considered non-responsive to this solicitation. Firm's that are not current on all of the required prequalification categories found in [MoDOT's Approved Consultant Prequalification List](#) at the date of the solicitation expiration will be considered non-responsive.

<b>Job No:</b>	J6S3278
<b>Location:</b>	Route H from north of Chain of Rocks Drive to Adelaide Avenue.
<b>Proposed Improvement:</b>	The proposed improvements include pavement rehabilitation and resurfacing, signal modifications, pavement marking, misc. drainage, concrete median to accommodate road diet.
<b>Length:</b>	3.65 miles
<b>Approximate Construction Cost:</b>	\$5.6 million

<b>Consultant Services Required:</b>	Scope of Services - The consultant will provide professional, technical and other personnel, equipment, material, and all other things necessary for inspection, testing and administration of the project along Route H in St. Louis City. Services to be provided by the consultant include field inspections of all work and contract activities, on-site quality assurance materials testing, project documentation, material reporting, measurement and payment, change order and estimate generation, attendance of meetings, and preparation of as-built plans. The consultant will be required to use AASHTOWare Project for all project documentation and record keeping. The consultant must be knowledgeable and experienced in the types of construction work to be performed on the project. Consultant shall be Advanced Work Zone certified, and technician certified in concrete field and concrete strength. Project will require night work at times especially during asphalt pavement work.
<b>Other Comments:</b>	Interviews or presentation will not be required for the consultant selection.  Job J6S3278 is scheduled for a June 2024 contract award with construction anticipated to commence late 2024. The project is anticipated to complete late 2025.  Tentative Date of Consultant Selection-April 15, 2024.
