It should also include any other information which might help us in the selection process, including key personnel you would assign to the project and the backgrounds of those individuals, and any sub-consultants you would propose to use, and an indication of your firm's approach to promoting and developing a diverse workforce. MoDOT is committed to reflecting the diversity of the communities we serve and we expect our partners to do the same. We will utilize the consultant information already on file so we will not need a lengthy submittal of other general company information. In addition, please attach one page with detailed information on similar projects that your key personnel have worked on. Indicate the role your key personnel played in the projects and include reference contact information.

DBE firms must be certified by the Missouri Department of Transportation in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any projects they feel can be managed by their firm. We also encourage both DBE firms and non-DBE firms to consider joining MoDOT's Mentor/Protégé program whenever possible as part of a MoDOT project.

MoDOT will evaluate firms based on: Project Understanding & Innovation, Past Performance, Qualifications of Personnel Assigned, General Experience of Firm, Familiarity/Capability, Accessibility of Firm & Staff. Firm's not providing a response on approach to workforce diversity will be considered non-responsive to this solicitation. Firm's that are not current on all of the required prequalification categories found in [MoDOT's Approved Consultant Prequalification List](#) at the date of the solicitation expiration will be considered non-responsive.

<b>Job No:</b>	J6S3609 J6S3640
<b>Location:</b>	J6S3609: Route I-44 NOR from the Crawford County line to Route 47 and along I-44 SOR from Route WW to Route AF and at the intersections of SOR I-44 and Route 185 and Route WW.  J6S3630: Route N from Route O to Route 30, and from 0.5 miles west of Hunters Run Road to Route O and at Route O over Calvey Creek.
<b>Proposed Improvement:</b>	J6S3609 consists of pavement rehabilitation and resurfacing, guardrail upgrades, signage, ADA upgrades and signal upgrades.  J6S3630 consists of pavement rehabilitation and resurfacing, guardrail upgrades, signing and bridge deck sealing.
<b>Length:</b>	J6S3609 – 18.43 miles J6S3630 – 10.44 miles
<b>Approximate Construction Cost:</b>	\$9 million

<b>Consultant Services Required:</b>	Scope of Services - The consultant will provide professional, technical and other personnel, equipment, material, and all other things necessary for inspection, testing and administration of the projects. Services to be provided by the consultant include field inspections of all work and contract activities, on-site quality assurance materials testing, project documentation, material reporting, measurement and payment, change order and estimate generation, attendance of meetings, and close out of customer service call reports. The consultant will be required to use AASHTOWare Project for all project documentation and record keeping. The consultant must be knowledgeable and experienced in the types of construction work to be performed on the project. Consultant shall be Advanced Work Zone certified, and technician certified in concrete field and concrete strength. Project may require night work.
<b>Other Comments:</b>	Interviews or presentation will not be required for the consultant selection.  Jobs J6S3609 & J6S3630 are scheduled for a February 2024 contract award with construction anticipated to commence as early as spring 2024. The project is anticipated to complete as late as November 2025.
