Q1.	Anticipated NTP of April 1 – In regards bat roosting in the spec, no removal of potential roost trees can take place between 4/1-10/31. Will the city be taking the responsibility of identifying potential roosts tree in order for contractor to perform clearing and grubbing operations within the time constraints of the project?
A1.	No, clearing/removal of trees was deemed to have no effect on roosting bats. Clearing/removal of any trees requires MoDOT’s written approval.
Q2.	No details are provided for the Access Control Swing Gates or Concrete Trail Marker Posts?

A2.	Refer to specs in Section 03020 – Concrete trail Marker Posts for details. Refer to specs in Section 02308 – Fencing for Access Control Swing Gate details.
Q3.	No size/caliper is identified for Trees?

Q4.	Previous question clarified spoils can be wasted on site, but with the sites requiring more Fill than Cut, can on-site Borrow areas be identified to reduce the cost of importing suitable fill?
A4.	No, no on-site borrow areas can be identified. Suitable fill material must be imported from off-site.
Q5.	Excavation/Embankment quantities – how were these calculated, to subgrade of base rock or to finish grade at top of concrete trail? The cross sections are near illegible.
A5.	Earthwork was calculated using GEOPAK software to the bottom of the 6" trail pavement.
Q6.	Please confirm 4" of Aggregate Base is incidental to Concrete Trail and Concrete Pads?
A6.	4" Rock Base is incidental to Concrete Trail and Concrete Pads. This is denoted on Sheet 11 of the plan set and in the specs 2202.B.1 (02202 – Untreated Compacted Aggregate).
Q7.	Please clarify a count of Concrete Pads, as no dimensions or locations are called out on the plans?
A7.	4" Concrete Pad dimensions are shown on Sheet 11 of the plan set (5'x5').
Q8.	Please confirm Heavy wage rates will be used and not Building rates?
A8.	Wage rates are Heavy Highway.
