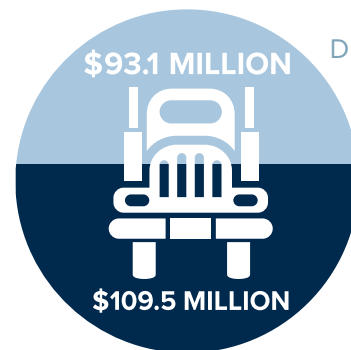

Annually, MoDOT processes more than **5,000 documents** related to intrastate carriers.



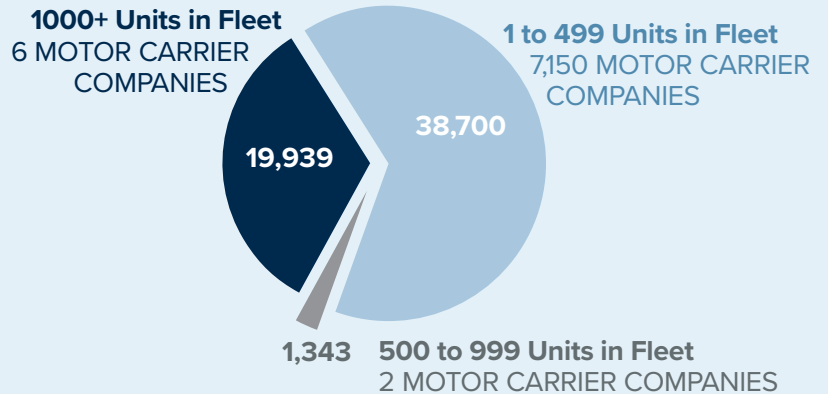
MCS conducts more than **1,000 safety audits** annually, helping new carriers master their safety responsibilities.
