Marshall Memorial Municipal Airport

Bids for the construction of the Project will be received at the City of Marshall located at 214 N Lafayette Ave, Marshall, MO 65340 until Wednesday, May 1, 2024 at 2:00 PM local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Schedule 1: Full depth reclamation of the existing parallel taxiway and connectors, excavation, subbase, base course, bituminous pavement, storm sewer, pavement markings, tie down anchors, topsoil borrow, seeding, fertilizing and mulching.

Schedule 2: Airfield electrical, taxiway edge lighting, lighted signs, vault work.

Schedule 3: BIL Funded- Pavement removal, excavation, geotextile fabric, subbase, base course, bituminous and concrete pavement, tie down anchors.

Schedule 4: BIL Funded- Excavation, geotextile fabric, subbase base course, bituminous pavement, topsoil, seeding, fertilizing and mulching.

Work shall meet all requirements for federal funding, including but not limited to Buy America, Davis-Bacon Prevailing Wage and a 5% DBE goal.
