The proposed work includes: the construction of approximately one-half mile of 10-foot wide, concrete, shared-use bicycle and walking trail near the Blue River Levee from E. 95th Street to Prospect Avenue in the City's 5th Council District. This trail will connect to the existing Blue River Trail at E.95th Street and travel north along the Blue River to meet up with Prospect Avenue north of the Prospect Avenue Bridge that crosses the Blue River. All bidders are encouraged to attend the pre-bid meeting.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The Kansas City, Missouri (OWNER) hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

Sec. 102.2 of the Missouri Standard Specifications for Highway Construction will be waived for this project. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Kansas City, Missouri reserves the right to reject any or all bids.

The DBE Goal for this project is 8%.

No 2nd tier subcontracting will be allowed on this project.
