October 2022 Calendar Year Financial Statements

The October 2022 financial statements for the Medical and Life Insurance Plan are attached. The plan's funded status is \$40.3 million with a calendar year to date net loss of \$9.1 million compared to the previous year's net income of \$131,000. The current month's net loss is \$4.8 million.

Operating revenues increased approximately \$400,000 from \$126.8 million to \$127.2 million compared to calendar year 2021. This increase is the net result of decreases in both Medical Premiums and Prescription Formulary Rebates and an increase in Medicare Reimbursement compared to 2021. The Medicare Reimbursement increase is due to the timing of payments received from Medicare. Additionally, the Nonoperating revenues/(expenses) decreased \$3.3 million compared to calendar year 2021. This decrease is primarily due to a reduction in the market value of investments. Market value is the amount securities can be sold in the market on any given day, and, as interest rates rise, the market value of investments decreases.

Operating expenses are \$132.8 million compared to \$126.5 million in the previous calendar year. This \$6.3 million increase is primarily due to higher Medicare Prescription Drug and Medical Claims Expenses. The Medical Claims Expense increase results from an increase in the average cost of claims from more expensive claims compared to calendar year 2021.

The current month Operating loss of \$4.6 million is primarily due to higher Medical Claims Expenses.

The Incurred But Not Reported (IBNR) Claims are adjusted biannually, typically in February and June. Based on the current actuarial report issued in June, the IBNR liability is \$10.8 million compared to the previous year's \$12.1 million.
