SEALED PROPOSALS for the Ralls County Bridge Replacement Program, consisting of:

Construction of one (1) single span (30') pre-cast slab or channel beam bridge.

Structure No. 19100221 Located approximately 2.5 miles South of Center, Missouri on Garden Grove Lane Road in Section 11, Township 54N, Range 6W in Ralls County, Missouri.

WILL be received until:

10:00 A.M. on Thursday, January 18th, 2018

at the office of County Clerk, Ralls County Courthouse, New London, MO 63459 and at that time will be publicly opened and read.

Any and all bids received after the time specified above will be returned unopened.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L.87-581; 76 Stat. 357) and implementing regulations. The higher of the Federal or State Wage rates shall apply.

Bidders are required to submit the corresponding documentation of enrollment in the E-Verify program. This documentation includes the Memorandum of Understanding between the company and Department of Homeland Security and the Affidavit of Compliance. MoDOT will accept the first page and the signature page of the agreement as proof of participation.

The County of Ralls hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
