RAILROAD AVENUE AND SIMPSON STREET SIDEWALK IMPROVEMENTS RUSSELLVILLE, COLE COUNTY, MISSOURI FEDERAL AID PROJECT NO. TAP-9901(526)

Sealed bids for Railroad Avenue and Simpson Street Sidewalk Improvements, will be received at: Russellville City Hall, 13203 Railroad Avenue, Russellville, MO 65074 until **2:00 o'clock P.M.** (Prevailing Local Time) on the **28th day of January, 2025**, and at that time will be publicly opened and read. If submitting the bid by mail, it is to be submitted in a sealed envelope addressed to the City of Russellville, P.O. Box 128, Russellville, MO 65074.

The proposed work includes: Construction of sidewalk, sidewalk ramps, driveway approaches along Railroad Avenue and Simpson Street as well as improvements at the intersection of Railroad Avenue and Simpson Street. The project will utilize City Right-of-Way and City maintenance easements for construction of the sidewalk as well as temporary construction easements for grading and tie-ins parallel to the proposed sidewalk.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Russellville hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
