### Angela Long, 91, De Soto, Dies This Morning

Mrs. Angela A. Long, 91, of near De Soto, widow of Judge James J. Long, who was justice of the peace in Plattin Township for many years, died of infirmities at 1:30 a.m. today at Wood nursing home, Route JJ, near De Soto, where she had been a patient for two months. She has 88 living direct descendants,

Mrs. Long made her home with a son, Gilbert J. Long, county juvenile officer, until entering the nursing home. A resident of Jefferson county since 1933, she was born in St. Louis, November 6, 1876, daughter of the late John and Ann Padberg. A son Oliver, preceded her in death.

A devout Catholic, Mrs. Long was a member of the St. Rose of Lima church, St. Ann's sodality, and the Daughters of Isabella.

Survivors besides her son Gilbert are two other sons, Vincent, J. Long of Greenwich, Conn., and Frank E. Long of Las Vegas, Nev. a daughter, Mrs. Angela Weber, of Crestwood; two sisters, Mrs. Agnes Lucas and Mrs. Hilda Killoran, both of St. Louis; 23 grandchildren; 60 great-grandchildren; and a great-great-grandson.

Mr. and Mrs. Paul F. Coleman, old state road (near old McNutt school), north of Festus, were notified Monday that their son, Army Specialist Five James F. Coleman, 20 was killed in combat February 29 in Vietnam.

James, born August 4, 1947, in St. Louis, was a 1965 graduate of Herculaneum high school, and attended Jefferson college for one year. He entered the service Oct. 27, 1966, received his basic training at Fort Leonard Wood, Mo., and Fort Polk, La. He arrived in Vietnam last April 11.

Surviving with his parents are two brothers, Johnny Coleman, Pevely, and Tommy, at home, a senior at Herculaneum high school, and grandparents, Mrs. Fabian (Mary) Coleman, a patient at Festus Rest home, and Mrs. John Gegg, Ste. Genevieve.

Paul is employed by Missouri Natural Gas company. James is about the 10th Jefferson county youth killed in Vietnam and the fifth in the last few months.
