Notice is hereby given that the City of Dardenne Prairie will receive sealed proposals at City Hall, 2032 Hanley Road, Dardenne Prairie, Missouri until **9:00 am local time, November 15, 2023 for the Stump Road Reconstruction and Improvements STP-7302(682), City Project No. 971670**. All bids will be publicly opened and read shortly thereafter.

The Scope of the Work shall include...

Grading, paving, drainage, signal, and retaining wall improvements between Missouri Route N and Feise Road, a distance of about 2,300 linear feet, more or less.

The bid proposal shall be made on a form of proposal, provided in the specifications and delivered in a sealed envelope clearly marked on the outside **Bid No. 971670-01** to the City Clerk's Office on or before the time specified above. No facsimiles will be accepted. The proposal shall be accompanied by a bid bond, certified check or cashier's check of a bank or trust company in St. Charles County, St. Louis County, or in the City of St. Louis for an amount not less than five (5%) percent of the bid amount. The amount of the check shall be forfeited to the City if the bidder neglects or refuses to enter into a contract or to furnish bond after his proposal has been accepted.

The City of Dardenne Prairie will award the project to the lowest, responsive, responsible bidder. The City reserves the right to require the successful bidder to file proof of his ability to properly finance and execute the project together with his record of successful completion of similar projects. Pursuant to MoDOT approval, the City reserves the right to reject any and all bids, offers, or proposals submitted, or to advertise for new bids. The City reserves the right to defer the acceptance of any proposal and the execution of a contract for a period not exceeding sixty (60) days after the date of opening of the bids. The successful bidder to whom the contract has been awarded shall sign the contract and performance bond and other required certificates in **triplicate** and return the signed documents within seven (7) days after the date of their receipt.

The successful bidder shall furnish a performance bond and payment bond for one hundred (100%) percent of the contract amount and shall file certificates with the City that he has obtained and will continue to carry workmen's compensation insurance, public and private liability, and property damage insurance, and builder's risk insurance in an adequate amount for the duration of the contract.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City reserves the right to remove a portion of the work if insufficient funds are available to cover the entire amount of the bid.

The City of Dardenne Prairie hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, Current Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

The DBE Goal for this project is **12%**.

No 2nd tier subcontracting will be allowed on this project.

(1) **PROPOSED WORK:** The proposed work, hereinafter called the work, includes:

The Stump Road Improvement Project – Grading, paving, drainage, signal, and retaining wall improvements between Missouri Highway N and Feise Road, a distance of about 2,300 linear feet, more or less.

(2) **COMPLIANCE WITH CONTRACT PROVISIONS:** The bidder, having examined and being familiar with the local conditions affecting the work, and with the contract, contract documents, including the current version of the St. Charles County Standard Specifications for Arterial Highway Construction, their revisions, and the request for bid, including appendices, the special provisions and plans, hereby proposes to furnish all labor, materials, equipment, services, etc., required for the performance and completion of the work. All references are to the St. Charles County Standard Specifications for Arterial Highway Construction, as revised, unless otherwise noted.

All storm sewer construction on this project shall be pursuant to the Metropolitan St. Louis Sewer District's (MSD) Standard Construction Specifications for the Sewer and Drainage Facilities, 2009, which may be downloaded from the MSD website.
