**Protect** - Promoting Resilient Operations for Transformative, Efficient, and Cost-Saving Transportation Program.  
\* Usually 80% Federal & 20% State funds.

**CRP** - Carbon Reduction Program.  
\* Usually 80% Federal & 20% State funds.
